SlabStitch[™] LIMITED WARRANTY

SlabStitchTM Structural Systems its products to be free from manufacturing defect for 5 years, as detailed in the "LIMITED WARRANTY" section below. The warranty provides for replacement of defective components should a SlabStitchTM strap fails from lateral loading or deteriorate due to manufacturer's defects or workmanship of material.

Manufacturer will furnish new replacement product, as replacement for defective material. Failure due to acts of nature i.e. earthquake, erosion, foundation settlement etc., or soil pressure uplift is excluded. This warranty covers the quality of SlabStitchTM Structural System components, and does not cover installation craftsmanship. Installer workmanship and service guarantee should be obtained from the licensed contractor installer. Limitations include: Spacing shall be no more than 1 ft on center. Components are designed to maximize tensile strength for lateral loading and make no claims for shear loading due to settlement. Warranty is for original owner and non-transferable. There are no other warranties by SlabStitchTM of any nature whatsoever expressed or implied including any warranty of accountability or fitness for a particular purpose in connection with this product. SlabStitchTM shall not be liable for damages of any sort including, remote or consequential damages resulting from any legal theory for special or consequential damages.

CONTRACTOR

Contractor shall have the right to warrant labor. It is highly recommended that the contractor keep records of the installation process, including the torque achieved for each strap, take pictures of original repair, clearly identifying strap spacing, and retain records. In the event of a repair failure, contractor has the right to repair the area of failure only. It is noted that some cosmetic variation may appear. Costs as to water replacement, chemicals, land and loss of use are not covered. Warranty is void unless account has been paid in full.

1. LIMITED WARRANTY. SlabStitchTM warrants, for a period of five (5) years (the "Limited Warranty Period") from the date of purchase of SlabStitchTM Structural System products and is free from defects in material and workmanship. This Limited Warranty extends only to the Covered Person: (i) the first retail purchaser of the Product; (ii) or the first owner of the structure to which the Product is applied 2. WHAT WE WILL DO. If, during the Limited Warranty Period, the Product is defective in material or workmanship, SlabStitchTM will, in its sole discretion, either replace the defective portion of the Product, or, during the first (1st) through the fifth (5th) year, or reimburse the Covered Person for the original retail cost of the defective portion of the Product.

SlabStitchTM WILL NOT REFUND OR PAY ANY COSTS IN CONNECTION WITH LABOR OR ACCESSORY MATERIALS. 3. WHAT YOU MUST DO/CONDITIONS OF LIMITED WARRANTY. Warranty coverage under this Limited Warranty shall be subject to the following terms and conditions: (A) A Covered Person must provide certified letter written notice to SlabStitchTM within thirty (30) days after discovery of any claimed defect covered by this Limited Warranty and before beginning any permanent repair. The notice

must describe the location and details of the claimed defect and any additional information necessary for SlabStitchTM to investigate the claim. Photos of the Product, showing the claimed defect must accompany the notice. A claimant under this Limited Warranty must provide proof to SlabStitchTM that such claimant is a Covered Person as defined in Section 1 above. (B) The Product must be installed according to SlabStitchTM printed installation requirements and must comply with all building codes adopted by federal, state or local governments or government agencies applicable to the installation. (C)Upon discovery of a claimed defect, a Covered Person must immediately, and at a Covered Person's own expense, provide for protection of all property that could be affected until the claimed defect is remedied if applicable. Before any permanent repair to the Product, a Covered Person must allow SlabStitchTM or a SlabStitchTM authorized agent to enter the property and structure where the Product is installed, if applicable, and examine, photograph and take samples of the Product. Any repairs initiated by or on behalf of a Covered person without prior authorization from SlabStitchTM may void the warranty. 4. WHAT IS NOT COVERED. This Limited Warranty does not cover damage or defects resulting from or in any way attributable to: (a) The improper handling or installation of the Product, including, without limitation, failure of the Product to be installed in strict compliance with manufactures recommendations, Warranty set forth in Section 3 of this Limited Warranty and/ or improper installation); (b) Further processing, modification or alteration of the Product after shipping from (c) Failure due to acts of nature i.e. earthquake, erosion, foundation settlement etc., or soil pressure uplift is excluded.; (d) Neglect, abuse, or misuse; (e) Repair or alteration; (f) Settlement or structural movement and/or movement of materials to which the Product is attached; (g) Damage from incorrect design of the structure; (h) Exceeding the maximum designed loads; (h) Acts of God including, but not limited to, tornados, hurricanes, floods, earthquakes, severe weather or other natural phenomena, (including, but not limited to, unusual climate conditions); or (1) Any cause other than defects in material and workmanship attributable to SlabStitch[™]. 5. LIMITATION OF LIABILITY. IN NO EVENT SHALL SlabStitch[™] BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, INCLUDING BUT NOT LIMITED TO, ANY CLAIMS OF PROPERTY DAMAGE, BASED UPON BREACH OF WARRANTY, BREACH OF CONTRACT, TORT, OR ANY OTHER LEGAL THEORY. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation may not apply to you. 6. LIMITATION OF WARRANTY. THE ABOVE LIMITED WARRANTY IS THE EXCLUSIVE WARRANTY FOR THE PRODUCT. This Limited Warranty gives you specific legal rights, and you may have additional rights, which vary from state to state. 7. ENTIRE AGREEMENT. This Limited Warranty contains and represents the only warranty extended by SlabStitchTM for the Product. No employee or agent of SlabStitchTM or any other party is authorized to make any other warranty in addition to those made in this Limited Warranty. 8. MODIFICATION OR DISCONTINUATION OF PRODUCTS. SlabStitchTM reserves the right to discontinue or modify the Product at any time without notice. In the event that repair or replacement of the Product pursuant to this Limited Warranty is not possible, SlabStitchTM will fulfill obligation under this Limited Warranty by either replacing the defective portion of the Product, or, during the first (1st) through the fifth (5th) year, or reimbursing the Covered Person for

the original retail cost of the defective portion of the Product.
